WHEREAS, We hold the duty and royal prerogative to ennoble deserving subjects, fully mindful of the inherent honour, duty, and nobility associated with the rank of Baron within Our realm;

And **WHEREAS**, Erik White has displayed meritorious service, unwavering loyalty, and profound commitment to Our noble realm of Kaharagia, demonstrating an undeniable potential for augmented contribution within the esteemed ranks of nobility;

And **WHEREAS**, We hold steadfast confidence in the exemplary integrity, dedication, and noble character consistently showcased by Erik White in his service to Our realm;

And **RECOGNISING**, with deep reverence for tradition, the preservation of noble virtues, and the pursuit of excellence, the need to acknowledge such outstanding service in accordance with the customs, traditions, and laws governing Our realm;

Now, **THEREFORE**, We, in Our Sovereign capacity, having considered these factors and with the authority vested in Us, do hereby decree as follows:

Article I: Creation and Heredity of the Title

1.1 Erik White is hereby invested and ennobled as Baron White, who shall henceforth enjoy all rights, privileges, duties, and responsibilities incumbent upon the noble rank of a Baron of Our realm.

1.2 He shall bear the title and style of 'His Excellency The Noble and Highborn The Baron White', and all individuals shall address him with due deference and respect.

1.3 The title of Baron White is declared hereditary, to be passed to the legitimate first-born or adopted heir, irrespective of their sex.

1.4 In the absence of a legitimate heir, the title shall pass to the most senior member of the family closest to the previous Baron. If no suitable family member exists, it shall revert to the Crown and cease to exist.

1.5 The lawful spouse and children of Baron White shall hold the title and honour in courtesy, enjoying the respect and privileges in accordance with the laws and customs of our realm.

Article II: Enactment and Enforcement

2.1 This decree shall take effect immediately upon its promulgation.

2.2 All subjects of the realm, court officials, and servants of the Crown shall adhere to this decree.

2.3 Failure to accord the proper respect, privileges, and recognition to Baron White, his lawful spouse and children shall be considered an affront to the Crown and may result in punishment under the laws of our realm.

2.4 The enforcement of this decree shall rest with the relevant authorities and the Crown to uphold all rights, privileges, duties, and responsibilities incumbent upon the title of Baron White.
